How to Enter Details:

This is a colouring in competition. Consumers can pick up an entry from any participating Go Vita store from a staff member. Consumers then need to hand in their completed entry to a participating Go Vita store before 31 March 2010.

The winning entry will be judged by store staff in the participating store based on skill, the prizes will be awarded to the parent or guardian of any winners under 18 years of age.

Terms and Conditions of Entry:
